##### **2. Delivery Period:**

a) Machine should be Delivered, Installation, Testing, Commissioning & Training to be done within Three (3) Months from the date of issue of Contract.

b) The vendor is responsible for delivering the material and duly unloading the same at the General Store of India Government Mint, Kolkata after taking necessary security clearance from CISF at the main gate by showing the driving license, vehicle registration etc. and necessary documents like invoice, delivery challan, copy of Purchase Order, e-way bill etc are to be handed over to Store-in-Charge.

##### **3. Terms and Mode of payments:**

(i) 90% on receipt and acceptance of goods by the user section at destination and on production of all required documents by the supplier. (Acceptance means goods supplied in proper condition at India Govt. Mint, Kolkata as well as meeting other terms and conditions of Purchase order.)

(ii) Balance 10% on successful installation & commissioning and issuance of Final Acceptance Certificate (FAC) by India Government Mint, Kolkata.

##### **4. Transportation of Domestic Goods:**

##### **5. Packing:**

Machines should be suitably packed. The packing should be weather proof and should be made water proof to prevent damage during transit. The supplier will also be responsible for unloading and stacking at India Government Mint, Kolkata Store as per instruction of competent authority.

#### **6. Insurance:**

The supplier shall make arrangements for insuring the goods against loss or damage, incidental to manufacture or acquisition, transportation, storage and delivery. The Supplier shall be responsible till the entire goods contracted for arrive in good condition at destination. The transit risk in this respect shall be covered by the supplier by getting the goods duly insured. The insurance cover shall be obtained by the supplier in its own name not in the name of India Government Mint, Kolkata or its consignee.

#### **7. Quantum of LD:**

If the supplier fails to deliver any or all of the machines or fails to perform the services within the time frame(s) incorporated in the contract( for both with respect to delivery of machine as well as Installation, commission, training and Final Acceptance Test (FAT) as mentioned in delivery schedule), India Govt. Mint, Kolkata shall, without prejudice to other rights and remedies available to India Govt. #### **15. Qualification/ Eligibility Criteria**

Bidder should meet the following qualification criteria as mentioned in A, B & C.

##### **A. EXPERIENCE & PAST PERFORMANCE:**

The bidder (manufacturer or principal of authorized representative - hereinafter referred simply as 'The Bidder') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned "Mechanical Power Press (40-45T)" with the same or higher specifications of at least One(1) number as described in Technical Specification in last five years ending on 31.03.2022. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

**B. CAPABILITY - EQUIPMENT & MANUFACTURING FACILITIES:**

The bidder must have an annual capacity to manufacture and supply at least One (1) number "Mechanical Power Press (40-45T) ".

**Note:**

(i) In support of the Capability, the bidder has to submit copy of supporting documents i.e. details of equipment and manufacturing facilities, engineers/managers details, number of skilled labors available with the firm, etc.

(ii) For verifying the Capability/Capacity, India Government Mint, Kolkata reserves the right to depute its authorized representatives at the worksites of the supplier. In the event, the firm is found not having capability/capacity, their offer is liable to be rejected.

**C. FINANCIAL STANDING:**

The average annual financial turnover of the bidder firm (manufacturer or principal of authorized dealer) during the last three years, ending on 31.03.2022, should be at least Rs.8,18,920/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

**18. Eligible Goods and Services (Origin of Goods & Services):**

(i) All goods and services to be supplied and provided for the contract shall have the origin in India or in the countries with which the Government of India has trade relations.

(ii) The word "origin" incorporated in this clause means the place from where the goods are mined, cultivated, grown, manufactured, produced or processed or from where the services are arranged.

**19. Special Condition:** Supplier should file the returns pertaining to TCS (Section 206C (1H) for TCS collected, in the time and provide the TCS certificate to IGMK.
