Mint, Kolkata or the supplier may seek recourse to settlement of disputes through arbitration act 33.2. Disputes arising out of any breach of contract pertaining to this tender shall be settled in the court of competent jurisdiction located within Kolkata only.

## **26. Scope of Work:**

- (i) Comprehensive AMC rate is applicable for 1 year and is applicable for machine in working condition.
- (ii) Comprehensive AMC service will be provided in Max. 3 days time except force majeure clause. Beyond 3 days Rs. 550/- will be charged per day as penalty.
- (iii) Comprehensive AMC service includes 4 preventative visits in a year.
- (iv) Defective materials due to manufacturing defects/mal-function will be repaired /replaced free of cost. However, damaged parts during movement or burn parts or physically damaged parts due to natural calamities will not be covered under Comprehensive AMC. Replaced/faulty parts will be replaced and taken away by M/S BEL as they are property of M/S BEL.
- (v) Rubber parts like conveyor belt, Lead flaps, plastic switches and UPS batteries are not covered under CAMC. These will be replaced on chargeable basis.
