3. Delivery Period:

- a) Entire work to be completed within Twenty Four (24) Weeks from the date of issue of Contract.
- b) The vendor is responsible for delivering the goods and duly unloading the same at the General Store of I ndia Government Mint, Kolkata after taking necessary Gate Pass from CISF at the main gate by showing th

e ID proof, Purchase Order & invoice etc. and necessary documents like invoice, delivery challan, copy of P O, e-way bill, bank details in company letter head duly sealed and signed etc. are to be handed over to Sto re- in- charge.

4. Terms and Mode of payments:

- (i) 90% on receipt and acceptance of goods by the user section at destination and on production of all required documents by the supplier. (Acceptance means goods supplied in proper condition at India Govt. Mint, Kolkata as well as meeting other terms and conditions of Purchase order.)
- (ii) Balance 10% on successful installation & commissioning and issuance of Final Acceptance Certificate (F AC) by India Government Mint, Kolkata.

5. Warranty:

- (a) The supplier warrants that the goods supplied under the contract is new, unused and incorporate all re cent improvements in design and materials unless prescribed otherwise by India Govt. Mint, Kolkata in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect ari sing from design, materials (except when the design adopted and / or the material used are as per specific ation of India Govt. Mint, Kolkata) or workmanship or from any act or omission of the supplier, that may de velop under normal use of the supplied goods under the conditions prevailing in India.
- (b) The machine along with all accessories supplied & installed under this contract shall be warranted agai nst any type of defects arising due to design, faulty material, workmanship, poor packing and damage during transportation and unloading/shifting/lifting, storage and for trouble free operation.
- (c) The Warranty shall remain valid on **Compressor & Entire Machine** for a period of **Twelve (12) mon ths** from the date of final acceptance certificate (FAC) issued by India Government Mint, Kolkata and shall include repairing and replacing of defective parts, workmanship and services, required operational and mai ntenance support services at free of cost, which are essentially required to put the entire system in normal operation.
- (d) In case of any claim arising out of this warranty, India Govt. Mint shall promptly notify the same in writing to the supplier.
- (e) Upon receipt of such notice, the supplier shall, with all reasonable speed and time, repair or replace the defective goods free of cost, at the ultimate destination. The supplier shall take over the replaced goods af ter providing their replacements and no claim, whatsoever shall lie on India Govt. Mint, Kolkata for such re placed goods thereafter.
- (f) In the event of any rectification of a defect or replacement of any defective goods during the warranty p eriod, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of India Govt. Mint, Kolk ata.
- (g) If the supplier, having been notified, fails to rectify/ replace the defect(s) within a delivery period, India Govt. 8. Insurance:

9. Ouantum of LD:

Mint, Kolkata shall, without prejudice to oth er rights and remedies available to India Govt. 16. Qualification/ Eligibility Criteria

A. EXPERIENCE & PAST PERFORMANCE:

The bidder (manufacturer or principal of authorized representative - hereinafter referred simply as 'The Bid der') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, er ected, commissioned "22 TR ductable packaged AC" with the same or higher specifications of at least O ne(1) number in last five years ending on 31.03.2023. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

Note:

(i) In Support of Experience & Past Performance, Copy of Purchase Order/Supply/Work Order; respective co mpletion certificate (from the previous buyer of the Machine) and Contact Details (from the previous buyer of the Machine) to be enclosed along with the tender.

B. CAPABILITY - EQUIPMENT & MANUFACTURING FACILITIES:

The bidder must have an annual capacity to manufacture and supply at least One (1) number "22 TR duct able packaged AC".

Note:

- (i) In support of the Capability, the bidder has to submit copy of supporting documents i.e. details of equip ment and manufacturing facilities, engineers/managers details, number of skilled labors available with the firm, etc.
- (ii) For verifying the Capability/Capacity, India Government Mint, Kolkata reserves the right to depute its a uthorised representatives at the worksites of the supplier. In the event, the firm is found not having capabil ity/capacity, their offer is liable to be rejected.

C. FINANCIAL STANDING:

The average annual financial turnover of the bidder firm (manufacturer or principal of authorized dealer) d uring the last three years, ending on 31.03.2023, should be at least Rs.5.76 Lakhs as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Charter ed Accountant/Cost Accountant in India.

The bidder should not have suffered any financial loss for more than one year during the last three years, e nding on 31.03.2023.

- i) The net worth of the Bidder should not be negative on 31.03.2023 and also
- ii) The net worth of the Bidder should not have eroded by more than 30% in the last three years, ending on 31.03.2023.

Note:

- (i) For net worth erosion calculation of last three(3) years ending on 31.03.2023, audited balance sheet of l ast four(4) financial years i.e: 2019-20, 2020-21, 2021-22 & 2022-23 must be submitted.
- (ii) Supporting documents to be furnished as claim against the above Financial Standing: all financial standing data should be certified by certified accountants.
- (iii) Non-submission or incomplete submission of documents may lead to rejection of offer.

17. MSME & Make in India Status:

In case any bidder is submitting their bid as MSME and/or MII, the firm must be registered as a MSME & MII in GeM portal and Self-declaration along with documentary evidence in this regard must be submitted declaring that their MSME & MII status is updated in GeM portal also. In further evaluation stage if it is found that the firm is not registered as MSME and/or MII in GeM, but MSME certificate and/or MII declaration is submitted along with the bid, no exemption will be given and their offer may be rejected.

18. Price Preference for MSE:

MSE quoting price within price band L1 \pm 15% may be awarded 25% of the total tendered value provided t hey agree to match the L1 price. In case of more than one such eligible MSE, 25% quantity is to be distributed proportionately among these bidders. Within this, a purchase preference of 4% is reserved for MSEs owned by SC/ST entrepreneurs' and 3% is reserved for procurement from MSEs owned by women (if they participate in the tender process and match the L1 price, considering spirit of policy for enhancing the Govt. procurement from MSE.
