- a) The contract period will be for Twelve (12) months or up to the period by which the ceiling limit (total value of services) gets exhausted, whichever is later.
- b) The material has to be transported on "as and when required basis" and on intimation from India Govt. Mint, Kolkata.

#### 3. Terms and Mode of payments:

- a.
