- 1. 2. Delivery Period:

- a) The successful bidder/firm is required to complete the design, supply, installation, commission, training and final acceptance test (FAT) within Thirty Four(34) Weeks time from the date of issue of Contract.
- b) The supplier is responsible for delivering the Machine and duly unloading the same at the Medal Depart ment of India Government Mint, Kolkata after taking necessary security clearance from CISF at the main g ate of India Government Mint, Kolkata by showing the driving licence, vehicle registration etc. and necessary documents like invoice, delivery challan, copy of Purchase Order, e-way bill, bank details in company let ter head duly sealed & signed etc. are to be handed over to Store- in- charge.

3. Terms and Mode of payments:

- (i) 90% on receipt and acceptance of goods by the user section at destination and on production of all required documents by the supplier. (Acceptance means goods supplied in proper condition at India Govt. Min t, Kolkata as well as meeting other terms and conditions of Purchase order.)
- (ii) Balance 10% on successful installation & commissioning and issuance of Final Acceptance Certificate (F AC) by India Government Mint, Kolkata.

4. Warranty:

- (a) The machine along with all accessories supplied & installed under this contract shall be warranted against any type of defects arising due to design, faulty material, workmanship, poor packing and damage during transportation and unloading/shifting/lifting, storage and for trouble free operation.
- (b) The Warranty shall remain valid for a period of **Twelve (12) months** from the date of final acceptance certificate (FAC) issued by India Government Mint, Kolkata and shall include repairing and replacing of def ective parts, workmanship and services, required operational and maintenance support services at free of

cost, which are essentially required to put the entire machine in normal operation.

- (c) The firm will have to give written undertakings that the goods supplied under this contract are new, of the recent models and incorporate all recent improvements in design and materials unless provided other wise in the contract.
- (d) The bidder shall ensure that OEM/Manufacturers of machine/material offered under this contract shall s upport the equipment at least for a period of 10 years from the date of FAC.
- (e) In case of any claim arising out of this warranty, India Govt. Mint shall promptly notify the same in writing to the supplier. Upon receipt of such notice, the supplier shall, with all reasonable speed and time, repair or replace the defective goods or services or part thereof at the ultimate destination without any cost to India Government Mint, Kolkata.
- (f) If the supplier, having been notified, fails to rectify/ replace the defect(s) within the period as mentioned in para (e) above, India Govt. Mint, Kolkata may proceed to take such remedial action(s) as deemed fit by I ndia Govt. 5. Transportation of Domestic Goods:

6. Packing:

7. Insurance:

The supplier shall make arrangements for insuring the goods against loss or damage, incidental to manufa cture or acquisition, transportation, storage and delivery. 8. Quantum of LD:

If the supplier fails to deliver any or all of the machines or fails to perform the services within the time fra me(s) incorporated in the contract(for both with respect to delivery of machine as well as Installation, com mission, training and Final Acceptance Test (FAT) as mentioned in delivery schedule), India Govt. Mint, Kol kata shall, without prejudice to other rights and remedies available to India Govt. A. EXPERIENCE & PAST PERFORMANCE:

The bidder (manufacturer or principal of authorized representative - hereinafter referred simply as 'The Bid der') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, er ected, commissioned "**Special Purpose Blanking Press**" with the same or higher specifications of at least One(1) number in last five years ending on 31.03.2023. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

B. CAPABILITY - EQUIPMENT & MANUFACTURING FACILITIES:

The bidder must have an annual capacity to manufacture and supply at least One (1) number "Special Pu rpose Blanking Press".
