#### 2. Delivery Period:

- a) The bidder is required to deliver the Machine including Installation, Commissioning, Testing, Training an d Final Acceptance Test (FAT) to be completed within Eight (8) Weeks from the date of issue of Contract.
- b) The supplier is responsible for delivering the Machine and duly unloading the same at the Concerned De partment of India Government Mint, Kolkata after taking necessary security clearance from CISF at the main gate of India Government Mint, Kolkata by showing the driving licence, vehicle registration etc. and necessary documents like invoice, delivery challan, copy of Purchase Order, e-way bill, bank details in company letter head duly sealed & signed etc. are to be handed over to Store- in- charge.

## 3. Terms and Mode of payments:

100% payment will be made after issuance of Final Acceptance Certificate (FAC) by India Government Mint , Kolkata.

## 4. Warranty:

- (a) The machine along with all accessories supplied & installed under this contract shall be warranted against any type of defects arising due to design, faulty material, workmanship, poor packing and damage during transportation and unloading/shifting/lifting, storage and for trouble free operation.
- (b) The Warranty shall remain valid for a period of Twelve (12) months from the date of final acceptance c ertificate (FAC) issued by India Government Mint, Kolkata and shall include repairing and replacing of defe ctive parts, workmanship and services, required operational and maintenance support services at free of c ost, which are essentially required to put the entire machine in normal operation.

- (c ) The firm will have to give written undertakings that the goods supplied under this contract are new, of the recent models and incorporate all recent improvements in design and materials unless provided other wise in the contract.

The bidder (manufacturer or principal of authorized representative - hereinafter referred simply as 'The Bid der') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, er ected, commissioned "45 KW Vacuum Gold Bar Making Machine" with the same or higher specifications of at least One(1) number in last five years ending on 31.03.2023. At least one number of the product of fered for supply should be in successful operation for at least one year on the date of bid opening.

#### **B. CAPABILITY - EQUIPMENT & MANUFACTURING FACILITIES:**

The bidder must have an annual capacity to manufacture and supply at least One (1) number "45 KW Vacuum Gold Bar Making Machine".

#### Note:

(i) In support of the Capability, the bidder has to submit copy of supporting documents i.e. details of equip ment and manufacturing facilities, engineers/managers details, number of skilled labors available with the firm. etc.

#### **C. FINANCIAL STANDING:**
