#### 2. Delivery Period:

a) The bidder is required to deliver the Machine including Pre-Dispatch Inspection(PDI), if any, within Forty Eight (48) weeks from the date of issue of contract.

b) Installation, Commissioning, Testing, Training and Final Acceptance Test (FAT) to be Completed within Fi fty Two (52) Weeks from the date of issue of Contract.

c) The supplier is responsible for delivering the Machine and duly unloading the same at the Medal Depart ment of India Government Mint, Kolkata after taking necessary security clearance from CISF at the main g ate of India Government Mint, Kolkata by showing the driving licence, vehicle registration etc. and necessa ry documents like invoice, delivery challan, copy of Purchase Order, e-way bill, bank details in company let ter head duly sealed & signed etc. are to be handed over to Store- in- charge.

#### 3. Terms and Mode of payments:

100% payment will be made after issuance of Final Acceptance Certificate (FAC) by India Government Mint , Kolkata.

#### 4. Warranty:

(a) The machine along with all accessories supplied & installed under this contract shall be warranted agai nst any type of defects arising due to design, faulty material, workmanship, poor packing and damage duri ng transportation and unloading/shifting/lifting, storage and for trouble free operation.

(b) The Warranty shall remain valid for a period of **Twelve (12) months** from the date of final acceptance certificate (FAC) issued by India Government Mint, Kolkata and shall include repairing and replacing of def ective parts, workmanship and services, required operational and maintenance support services at free of cost, which are essentially required to put the entire machine in normal operation.

(c) The firm will have to give written undertakings that the goods supplied under this contract are new, of the recent models and incorporate all recent improvements in design and materials unless provided other wise in the contract.

(d) The bidder shall ensure that OEM/Manufacturers of machine/material offered under this contract shall s upport the equipment at least for a period of 10 years from the date of FAC.

(e) In case of any claim arising out of this warranty, India Govt. Mint shall promptly notify the same in writi ng to the supplier. Upon receipt of such notice, the supplier shall within a period of maximum 10 days to re pair or replace the defective goods or services or part thereof at the ultimate destination without any cost to India Government Mint, Kolkata.

(f) If the supplier, having been notified, fails to rectify/ replace the defect(s) within the period as mentioned in para (e) above, India Govt. #### 7. Insurance:

The supplier shall make arrangements for insuring the goods against loss or damage, incidental to manufa cture or acquisition, transportation, storage and delivery. #### 8. Quantum of LD:

If the supplier fails to deliver any or all of the machines or fails to perform the services within the time fra me(s) incorporated in the contract(for both with respect to delivery of machine as well as Installation, com mission, training and Final Acceptance Test (FAT) as mentioned in delivery schedule), India Govt. Mint, Kol kata shall, without prejudice to other rights and remedies available to India Govt. #### 16. Qualification/ Eligibility Criteria

#### A. EXPERIENCE & PAST PERFORMANCE:

The bidder (manufacturer or principal of authorized representative - hereinafter referred simply as 'The Bid der') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, er ected, commissioned "**Medal/Coin Stamping Press**" with the same or higher specifications of at least On e(1) number in last five years ending on 31.03.2023. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening.

#### Note:

In Support of Experience & Past Performance, Copy of Purchase Order/Supply/Work Order; respective comp letion certificate (from the buyer of the Machine) and Contact Details (from the buyer of the Machine) to be enclosed along with the tender.

#### **B. CAPABILITY - EQUIPMENT & MANUFACTURING FACILITIES:**

The bidder must have an annual capacity to manufacture and supply at least One (1) number "**Medal/Coi n Stamping Press**".

#### Note:

(i) In support of the Capability, the bidder has to submit copy of supporting documents i.e. details of equip ment and manufacturing facilities, engineers/managers details, number of skilled labors available with the firm, etc.

(ii) For verifying the Capability/Capacity, India Government Mint, Kolkata reserves the right to depute its a uthorised representatives at the worksites of the bidder. In the event, the firm is found not having capabilit y/capacity, their offer is liable to be rejected.

#### **C. FINANCIAL STANDING:**

1) The average annual financial turnover of the bidder firm (manufacturer or principal of authorized dealer) during the last three years, ending on 31.03.2023, should be at least **Rs.5.99 Crore** as per the annual rep ort (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chart ered Accountant/Cost Accountant in India.

2) The net worth of the Bidder should

a) not be negative on 31.03.2023 and

b) not have eroded by more than 30% in the last three years, ending on 31.03.2023.

#### Note:

1. Bidder to furnish stipulated documents along with tender in support of fulfillment of tender criteria. Further correspondence in this regard will not be entertained for any reason. Non-submission or incomplete submission of documents may lead to rejection of offer.

2. L1 firm will be declared from valid offers only those who submitted offer as per specification & as per all terms & condition of the tender. If there is any deviation in specification & if the offer is not found as per terms & condition of the tender, their offer will be treated as invalid/unresponsive offer.

3. Price to be mentioned only in price bid not in Techno commercial bid or any other place. If it is mentioned any other part other than price bid, the offer will be rejected.
