## 2. Delivery Period:

a) Machine should be Delivered, Installation, Testing, Commissioning & Training to be done within Three (3) Months from the date of issue of Contract.

b) The vendor is responsible for delivering the material and duly unloading the same at the General Store of India Government Mint, Kolkata after taking necessary security clearance from CISF at the main gate by showing the driving licence, vehicle registration etc. and necessary documents like invoice, delivery challan, copy of PO, e-way bill etc. are to be handed over to Store- in- charge.

## 3. Terms and Mode of payments:

100% payment will be made after issuance of Final Acceptance Certificate (FAC) by India Government Mint, Kolkata.

## 4. Warranty:

(a) The supplier warrants that the goods supplied under the contract is new, unused and incorporate all recent improvements in design and materials unless prescribed otherwise by India Govt. Mint, Kolkata in the contract. The supplier further warrants that the goods supplied under the contract shall have no defect arising from design, materials (except when the design adopted and / or the material used are as per specification of India Govt. Mint, Kolkata) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.

(b) The machine along with all accessories supplied & installed under this contract shall be warranted against any type of defects arising due to design, faulty material, workmanship, poor packing and damage during transportation and unloading/shifting/lifting, storage and for trouble free operation.

(c) The Warranty shall remain valid for a period of **Twelve (12) months** from the date of final acceptance certificate (FAC) issued by India Government Mint, Kolkata and shall include repairing and replacing of defective parts, workmanship and services, required operational and maintenance support services at free of cost, which are essentially required to put the entire machine in normal operation.

(d) In case of any claim arising out of this warranty, India Govt. Mint shall promptly notify the same in writing to the supplier.

(e) Upon receipt of such notice, the supplier shall, with all reasonable speed and time, repair or replace the defective goods free of cost, at the ultimate destination. The supplier shall take over the replaced goods after providing their replacements and no claim, whatsoever shall lie on India Govt. Mint, Kolkata for such replaced goods thereafter.

(f) In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of India Govt. Mint, Kolkata.

(g) If the supplier, having been notified, fails to rectify/ replace the defect(s) within a delivery period, India Govt. Mint, Kolkata may proceed to take such remedial action(s) as deemed fit by India Govt. Mint, Kolkata at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which India Govt. Mint, Kolkata may have against the supplier.

## 5. Transportation of Domestic Goods:

## **6. Packing:**

## **7. Insurance:**

The supplier shall make arrangements for insuring the goods against loss or damage, incidental to manufacture or acquisition, transportation, storage and delivery. The Supplier shall be responsible till the entire goods contracted for arrive in good condition at destination. The transit risk in this respect shall be covered by the supplier by getting the goods duly insured. The insurance cover shall be obtained by the supplier in its own name not in the name of India Government Mint, Kolkata or its consignee.

## **8. Quantum of LD:**

If the supplier fails to deliver any or all of the machines or fails to perform the services within the time frame(s) incorporated in the contract( for both with respect to delivery of machine as well as Installation, commission, training and Final Acceptance Test (FAT) as mentioned in delivery schedule), India Govt. Mint, Kolkata shall, without prejudice to other rights and remedies available to India Govt. Mint, Kolkata under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5 % of the delivered price of the delayed machines and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed machines' or services' contract price(s).

## **16. Qualification/ Eligibility Criteria**

### **A. EXPERIENCE & PAST PERFORMANCE:**

The bidder (manufacturer or principal of authorized representative - hereinafter referred simply as 'The Bidder') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned "High Precision Weighing Balance, Capacity minimum 15Kg" with the same or higher specifications of at least One(1) number as described in Technical Specification in last five years ending on 31.03.2023. At least one number of the product offered for supply should be in successful operation for at

east one year on the date of bid opening.

In Support of Experience & Past Performance, Copy of Purchase Order/Supply/Work Order; respective completion certificate (from the buyer of the Machine) and Contact Details (from the buyer of the Machine) to be enclosed along with the tender.

**B. CAPABILITY - EQUIPMENT & MANUFACTURING FACILITIES:**

The bidder must have an annual capacity to manufacture and supply at least One (1) number "High Precision Weighing Balance, Capacity minimum 15 Kg" as described in Technical Specification.

**Note:**

(i) In support of the Capability, the bidder has to submit copy of supporting documents i.e. details of equipment and manufacturing facilities, engineers/managers details, number of skilled labors available with the firm, etc.

(ii) For verifying the Capability/Capacity, India Government Mint, Kolkata reserves the right to depute its authorized representatives at the worksites of the supplier. In the event, the firm is found not having capability/capacity, their offer is liable to be rejected.

**C. FINANCIAL STANDING:**

The average annual financial turnover of the bidder firm (manufacturer or principal of authorized dealer) during the last three years, ending on 31.03.2023, should be at least **Rs.12.99 Lakhs** as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

i) The net worth of the Bidder should not be negative on 31.03.2023 and also

ii) The net worth of the Bidder should not have eroded by more than 30% in the last three years, ending on 31.03.2023.

**Note:**

(i) For net worth erosion calculation of last three (3) years ending on 31.03.2023, audited balance sheet of last Three(3) financial years i.e: 2020-21, 2021-22 & 2022-23 must be submitted.

**17. MSME & Make in India Status:**

In case any bidder is submitting their bid as MSME and/or MII, the firm must be registered as a MSME & MII in GeM portal and Self-declaration along with documentary evidence in this regard must be submitted declaring that their MSME & MII status is updated in GeM portal also. In further evaluation stage if it is found that the firm is not registered as MSME and/or MII in GeM, but MSME certificate and/or MII declaration is submitted along with the bid, no exemption will be given and their offer may be rejected.

**18. Price Preference for MSE:**

## **19. Eligible Goods and Services (Origin of Goods & Services):**

(i) All goods and services to be supplied and provided for the contract shall have the origin in India or in the countries with which the Government of India has trade relations.

(ii) The word "origin" incorporated in this clause means the place from where the goods are mined, cultivated, grown, manufactured, produced or processed or from where the service are arranged.

**20. Special Condition:** Supplier should file the returns pertaining to TCS (Section 206C (1H) for TCS collected, in the time and provide the TCS certificate to IGMK. In case of any Credit loss to IGMK by way of their failure to file Returns and provide TCS certificate in time, India Government Mint, Kolkata reserves the right to recover the amount equivalent to TCS paid along with applicable interest from the payment of further supplies.

## **21. GST Return:**

## **23. Resolution of Disputes:**

If dispute or difference of any kind shall arise between India Government Mint, Kolkata and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, depending on the position of the case, either the purchaser or the supplier shall give notice to the other party of its intention to commence arbitration. When the contract is with domestic supplier, the applicable arbitration procedure will be as per Indian Arbitration and Conciliation Act, 1996 as amended by Arbitration and Conciliation (Amendment) Act, 2015 and 2021. Mode of settlement of such contractual disputes/ differences shall be through Arbitration, to the India International Arbitration Centre.

## **24. Risk Purchase Clause :**

(a) If the supplier after submission of tender and due acceptance of the same, i.e. after notification of award of contract fails to abide by the terms and conditions of these tender documents, or fails to supply the deliverables as per delivery schedule given or at any time repudiates the contract, the purchaser shall have the right to:
