2. Delivery Period:

- a) The bidder is required to deliver and complete installation, commissioning and Final Acceptance Test (F AT) of the item within **03 (three) months** from the date of issue of Contract.
- b) The bidder is responsible for delivering the material and duly unloading the same at the General Store of India Government Mint, Kolkata after taking necessary security clearance from CISF at the main gate of In dia Government Mint, Kolkata by showing the driving licence, vehicle registration etc. and necessary docu ments like invoice, delivery challan, copy of Purchase Order, e-way bill, bank details in company letter hea d duly sealed & signed etc. are to be handed over to Store- in- charge.

3. Terms and Mode of payments:

It's a totally turn-key project. Supplier has to complete installation, commissioning, servicing, in all aspects . 100 % payment will be released only after installation, commissioning, & servicing. Final Acceptance Test (FAT) will be issued on the basis of above points.

4. Warranty:

24. Resolution of Disputes:
