#### 2. Delivery Period:

The bidder is required to carry out services within 90 (Ninety) days from the date of issue of Contract.

#### 3. Terms and Mode of payments:

100% on successful completion and acceptance of services by the user section of India Government Mint, Kolkata and on production of all required documents by the supplier.

#### 4. Warrantv:

The Warranty shall remain valid for a period of **One (01) year from the date of final acceptance** of the services by India Govt. Mint, Kolkata

#### 5. Insurance:

The supplier shall make arrangements for insuring the goods/services against loss or damage, incidental to manufacture or acquisition, transportation, storage and delivery. The Supplier shall be responsible till the entire goods contracted for arrive in good condition at destination. The transit risk in this respect shall be covered by the supplier by getting the goods duly insured. The insurance cover shall be obtained by the supplier in its own name not in the name of India Government Mint, Kolkata or its consignee. #### 6. Quantum of LD:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, India Govt. Mint, Kolkata shall, without prejudice to other rights and remedi es available to India Govt. Mint, Kolkata under the contract, deduct from the contract price, as liquidated d amages, a sum equivalent to the 0.5% of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

he right to:
