### **1. Terms and Conditions:**

Service to be started within Seven (7) days from the date of issue of contract. Total Contract period will be valid for Twelve (12) months or till the number of days ceases, whichever is earlier from the date of issue of contract. Service to be provided on as and when required basis after communication from India Government Mint, Kolkata.

### **3. Terms and Mode of Payments:**

Payment will be made on monthly basis after acceptance of service, submission of bills and suitability by the user department of India Government Mint, Kolkata.

### **4. Quantum of LD:**

If the supplier fails to perform the services within the time frame(s) incorporated in the contract, India Govt. Mint, Kolkata shall, without prejudice to other rights and remedies available to India Govt. Mint, Kolkata under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% of the delivered price of the delayed services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed services' contract price(s).

## **10. Price Schedule:**
