10. Option Clause: Purchaser reserves the right to increase the ordered quantity by 25% at any time, on same terms and condition till final delivery date of the contract, by giving reasonable notice even though the quantity ordered initially has been supplied in full before the last date of the delivery period.

11. Liquidated Damages:

In case your quotation is accepted, and order is placed on you, the supply against the order should be made within the period stipulated in the order. Purchaser reserves the right to recover any Loss sustained due to delayed delivery by way of penalty. Failure to supply the material or installation & commissioning or both within the stipulated period i.e. delivery period, shall entitle the Purchaser for imposition of Penalty without assigning any reasons @ 1/2% of the total value of the item covered in order as LD for each week or part thereof of delay. The total damages shall not exceed 10 (ten) per cent of the value of delayed goods.

12. If the deliveries are not maintained and due to that account the Purchaser is forced to buy the material at your Risk and Cost from elsewhere, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.

21. FAILURE & TERMINATION

(A) Cancellation of contract for Default: Without prejudice to any other remedy for breach of contract, like removal from the list of registered Vendors, by written notice of default sent to the Vendor, the contract may be terminated inwhole or in part :

(i) If the Vendor fails to provide any or all the material and service within the time period(s) specified in the contract, or any extension thereof granted.

(ii) If the Vendor fails to perform any other obligation under the contract within the period(s) specified in the contract or any extension thereof granted.

(B) Termination of Contract for convenience : India Govt. Mint, Kolkata may at any time terminate the Contract by giving you month's prior notice in writing to that effect and shall have the liberty to appoint any other agency to carry out your obligation under this contract.

22. Tender Validity 90 days from the date of opening of the bid.

23. Terms and Mode of Payments: Payment will be made on Quarterly basis after acceptance of service, submission of bills and suitability by the user department. (Acceptance means goods & services supplied in proper condition at India Govt. Mint, Kolkata as well as meeting other terms and conditions of Purchase order).

24. Resolution of Disputes: If dispute or difference of any kind shall arise between India Government Mint, Kolkata and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, depending on the position of the case, either the purchaser or the supplier shall give notice to the other party of its intention to commence arbitration. When the contract is with domestic supplier, the applicable arbitration procedure will be as per Indian Arbitration and Conciliation Act, 1996 as amended by Arbitration and Conciliation (Amendment) Act, 2015 and 2021. Mode of settlement of such contractual disputes/ differences shall be through Arbitration, to the India International Arbitration Centre.

Scope of Work (SoW) with Terms & Conditions:



i. This is a comprehensive service and maintenance contract for the period of 02 years. All spares and consumable required for maintenance work are in the scope of M/S Bharat Electronics Limited (hereinafter mentioned as M/S BEL).

ii. Defective materials due to manufacturing defects/mal-function will be repaired /replaced free of cost. However, damaged parts during movement or burn parts or physically damaged parts due to natural calamities will not be covered under Comprehensive AMC. Replaced/faulty parts will be replaced and taken away by M/S BEL as those are property of M/S BEL.

**Rubber parts like conveyor belt, Lead flaps, plastic switches and UPS batteries are not covered under CAMC. These will be replaced on chargeable basis.

iii. M/S BEL shall provide all necessary tools & tackles as part of servicing to their manpower for satisfactory completion of job.

iv. M/S BEL shall provide all consumable items to their manpower required to make job complete.

v. Comprehensive AMC service includes 4 preventative maintenance visits in a year on Quarterly basis. Complete cleaning of all movable part should be done by the service engineer during each visit. During this Annual Maintenance Contract period any breakdown maintenance call is made by India Government Mint, Kolkata, contractor shall be able to depute their representative within 48 hours at India Government Mint, Kolkata site. The breakdown visit will be a part of maintenance contract and no separate charges will be paid to M/S BEL for breakdown visit.

vi. Representative of M/S BEL shall attend to routine visits and other related activities during 09:30 AM to 06:00 PM on all working days at India Government Mint, Kolkata. However, breakdown maintenance may be taken up beyond office hours.

vii. Breakdown maintenance of failed equipment shall be carried out as and when necessity arises at no extra cost. Service engineer of contractor shall attend and repair such failure within 48 Hours (except force majeure clause) after intimation of failure to contractor's office, beyond this time penalty of Rs. 550/- will be levied per day as penalty.

viii. During maintenance and servicing, standard safety norms should be followed and all the safety & security of service engineer is the complete responsibility of the contractor itself.

26. Delivery Schedule:

Service to be started within Seven (7) days from the date of issue of India Government Mint, Kolkata PurchaseOrder and to be provided for Two (2) years from the date of first Service.
