#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### **1. Terms and Conditions:**

#### 2. Delivery Period:

Total Contract period will be valid for Twelve (12) months or till the number of days ceases, whichever is e arlier from the date of issue of contract. One (1) maintenance Service to be provided in every month for ea ch shutter gate, breakdown maintenance will have to attend within very next day.

#### 3. Terms and Mode of Payments:

Payment will be made on Quarterly basis after acceptance of service, submission of bills and suitability by the user department.

#### 4. Quantum of LD:

If the supplier fails to perform the services within the time frame(s) incorporated in the contract, India Govt . Mint, Kolkata shall, without prejudice to other rights and remedies available to India Govt. Mint, Kolkata u nder the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% of the delivered price of the delayed services for each week of delay or part thereof until actual delivery or p erformance, subject to a maximum deduction of the 10% of the delayed services' contract price(s).

**5.** The total cost inclusive of all as cited above on FOR India Govt. Mint, Kolkata (W.B) basis should be indic ated clearly both in words and figures in the price bid.

6. Documentary evidence to be submitted towards PAN & GST Registration Certificate.

**7.** Participating Bidder must submit sealed and signed copy of entire GeM bid document including the Scop e of Work. Also the participating bidder must submit sealed & signed Annexure I in their letter head & Ann exure II attached under Scope of Work.

**8.** All the supporting documents submitted along with this bid should be signed and sealed by the authoriz ed signatory of the firm mandatorily. The bid document shall not contain any erasure or overwriting, excep t as necessary to correct any error made by the tenderer and, if there is any such correction; the same sha II be initialled by the person(s) signing the tender.

**9.** The supplier has to provide GeM invoice during submission of bill for payment.

#### **10. Price Schedule:**

While quoting the price through GeM portal, the detailed price breakup along with GST percen tage must be mentioned and attached as pdf in the document attachment option of price bid mandatorily. Do not upload financial documents related to financial standings like audited balance sheets in the document attachment field of price bid, attach only the detailed price breakup of the quotation as m entioned above. #### 11. MSME & Make in India Status:

#### 13. Eligible Services (Origin of Services):

(i) All services to be supplied and provided for the contract shall have the origin in India or in the countries with which the Government of India has trade relations.

(ii) The word "origin" incorporated in this clause means the place from where the goods are mines, cultivat ed, grown, manufactured, produced or processed or from where the service are arranged.

If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, depending on the position of the case, either the purchaser or the s upplier shall give notice to the other party of its intention to commence arbitration. (a) If the supplier after submission of tender and due acceptance of the same, i.e. after notification of awar d of contract fails to abide by the terms and conditions of these tender documents, or fails to supply the de liverables as per delivery schedule given or at any time repudiates the contract, the purchaser shall have t he right to:

(i) Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores from ot her agencies at the risk and consequence of the supplier. The cost difference between the alternative arra ngement and supplier tendered value will be recovered from the supplier.

(b) Supplier has to abide by all the terms and conditions of tender.
