Work to be started within One (1) days from the date of issue of contract & the contract for AMC and or cal ibration service will be valid for twelve (12) months.

#### 3. Terms and Mode of payments:

Payment will be made on Quarterly basis after receiving of original invoice along with other necessary doc uments and suitability by the user department of India Government Mint, Kolkata.

#### 4. Insurance:

The supplier shall make arrangements for insuring the goods and services against loss or damage, inciden tal to manufacture or acquisition, transportation, storage and delivery. The Supplier shall be responsible til I the entire goods contracted for arrive in good condition at destination. The transit risk in this respect shal I be covered by the supplier by getting the goods duly insured. The insurance cover shall be obtained by the supplier in its own name not in the name of India Government Mint, Kolkata or its consignee. #### 5. Quantum of LD:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, India Govt. Mint, Kolkata shall, without prejudice to other rights and remedi es available to India Govt. Mint, Kolkata under the contract, deduct from the contract price, as liquidated d amages, a sum equivalent to the 0.5% of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

#### 11. Price Schedule:

While quoting the price through GeM portal, the detailed price breakup along with GST percentage must be mentioned and attached as pdf in the document attachment option of price bid mand atorily. #### 12. MSME & Make in India Status:

#### 14. Eligible Goods and Services (Origin of Goods & Services):

- (ii) The word "origin" incorporated in this clause means the place from where the goods are mines, cultivat ed, grown, manufactured, produced or processed or from where the service are arranged.

If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, depending on the position of the case, either the purchaser or the supplier shall give notice to the other party of its intention to commence arbitration. #### 19. Risk Purchase Clause:

## Scope of Work (SoW):

#### Description:

The scope of work for AMC of Vickers cum Brinell Hardness Tester, Vickers Hardness Tester and Digital Rockwell Hardness Tester in Die Department is as follows: -

- 1. Calibration of the 3nos hardness testing machines followed by servicing on quarterly basis should be carried out in a year.
- 2. Any breakdown call must be attended within 24hours.
- 3. Quarterly payment after bill submission with service report.
- 4. The AMC is for servicing and calibration without any spare parts.
- 5. If any spare parts are needed for the said machines, then the Contract awarded firm must inform India Government Mint, Kolkata who will arrange for the same.

#### Note for Bidders: -

- (i) The firms submitting their offers for the proposed AMC must be NABL accredited to ensure genuineness of the hardness testing of important items like matrices, punches, dies, collars, coin blanks, etc. being carried out.
