- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. 2. Delivery Period:

- a) Overall delivery period will be One (1) Year from the date of issue of Contract.
- b) As per requirement of India Government Mint, Kolkata, the successful bidder/firm will be intimated for d elivering the desired quantity. The firm has to supply the materials within 30 days' period from date of intimation by India Government Mint, Kolkata.
- c) The vendor is responsible for lifting & delivering the material and duly unloading the same at the Bullion Store of India Government Mint, Kolkata after taking necessary security clearance from CISF at the main g ate of India Government Mint, Kolkata by showing the driving licence, vehicle registration etc. and necessary documents like invoice, delivery challan, copy of Purchase Order, e-way bill, bank details in company let ter head duly sealed & signed etc. are to be handed over to Bullion Store- in- charge.

3. Terms and Mode of payments:

100% on receipt and acceptance of goods & services at destination by the user section of India Governme nt Mint, Kolkata and on production of all required documents by the supplier on every instalment. (Accept ance means goods supplied in proper condition at India Govt. Mint, Kolkata as well as meeting other terms and conditions of Purchase order.)

4. Warranty

- a. The supplier warrants that the goods supplied under the contract shall have no defect arising from desi gn, materials (except when the design adopted and / or the material used are as per specifications of India Government Mint, Kolkata) or workmanship or from any act or omission of the supplier, that may develop under normal use of the supplied goods under the conditions prevailing in India.
- b. The warranty shall remain valid for **Twelve (12) months** after the goods or any portion thereof as the c ase may be, have been delivered to the final destination and accepted by India Government Mint, Kolkata in terms of the contract or for fifteen months from the date of despatch from the supplier's premises for do mestic goods, whichever is earlier.
- c. In case of any claim arising out of this warranty, India Government Mint, Kolkata shall promptly notify the same in writing to the supplier. Upon receipt of such notice, the supplier shall, with all reasonable speed, repair or replace the defective goods or parts thereof, free of cost, at the ultimate destination.
- d. The supplier shall take over the replaced parts/ goods after providing their replacements and no claim, whatsoever shall lie on India Government Mint, Kolkata for such replaced parts/ goods thereafter. In the event of any rectification of a defect or replacement of any defective goods during the warranty period, the warranty for the rectified/ replaced goods shall be extended to a further period of twelve months from the date such rectified / replaced goods starts functioning to the satisfaction of India Government Mint, Kolkat a.
- e. If the supplier, having been notified, fails to rectify/ replace the defect(s) within a reasonable period, Indi a Government Mint, Kolkata may proceed to take such remedial action(s) as deemed fit by India Government Mint, Kolkata (including forfeiture of performance security or warranty security, if any), at the risk and expense of the supplier and without prejudice to other contractual rights and remedies, which India Government Mint, Kolkata may have against the supplier.

5. Replacement:

If the items delivered are rejected for any reasons, the firm has to lift & replace the same at their cost and risk.

6. Custody and return of material loaned to contractor:

i) Fine Silver (999) raw material will be provided by Purchaser i.e. India Government Mint, Kolkata. Whene ver raw material is required to be issued to the firm/contractor, it will be issued against appropriate material custody security.

The successful firm must submit total material custody security for an amount of ₹1,00,00,952/- (considering rate of fine silver as ₹ 95.680 per g (as on 05/02/2025) and total quantity of fine silver (999) to be provided as 104525 g)

The firm has to submit material custody security drawn in favour of 'S P M Corporation of India Limited', pa yable at Kolkata, from any Scheduled Commercial Bank in acceptable form (i.e. Account Payee Demand Dr aft/ Fixed Deposit Receipt/Bank Guarantee) valid till 60 days beyond the completion of delivery of finished product (silver plates).

In any case, the successful bidder has to submit necessary material custody security of \$20,00,190.40/- so as to be eligible for lifting the Fine silver (999) raw material proportionate to minimum 200 pcs of finished Silver plates.

7. Packing:

To be packed in an exquisite velvet box covering with soft foam and premium quality blue velvet outside a nd a silicon frame inside which is to be covered with suitable blue cloth to have proper fixed grooves to ac commodate wooden stand and silver plate. Top of the Box has to be printed with NTPC Logo in bold letters . Velvet Box has to be packed in a transparent pack or zip lock pouch along with a proper sticker of name of the person & employee ID who's plate has been packed inside. Silver Plate has also to be tightly packed separately with LD Polythene sheet before keeping it into the box to avoid any scratches. All the velvet bo xes have to be supplied in wooden carets instead of cartoon boxes in not more than 25 pcs in a single care t to prevent any damage. The packing should be weather proof and should be made water proof to preven t damage during transit. The supplier will also be responsible for unloading and stacking at Mint Bullion Sto re as per instruction of competent authority.

8. Insurance:

The supplier shall make arrangements for insuring the goods against loss or damage, incidental to manufa cture or acquisition, transportation, storage and delivery. The Supplier shall be responsible till the entire g oods contracted for arrive in good condition at destination. The transit risk in this respect shall be covered by the supplier by getting the goods duly insured. The insurance cover shall be obtained by the supplier in its own name not in the name of India Government Mint, Kolkata or its consignee. For details please refer t o clause 12 of General Conditions of Contract (GCC).

9. Quantum of LD:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, India Govt. Mint, Kolkata shall, without prejudice to other rights and remedi es available to India Govt. Mint, Kolkata under the contract, deduct from the contract price, as liquidated d amages, a sum equivalent to the 0.5% of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

10. Parallel Contracts

(i) Parallel contracts, with more than one bidder (for the same contract) may be concluded in the following

cases:

After due processing, if it is discovered that the quantity to be ordered is far more than what L1 alone is ca pable of supplying and there was no prior decision/ declaration in the bidding documents to split the quant ities, then the quantity being finally ordered may be distributed among the other bidders by counter offering the L1 rate in a manner that is fair, transparent and equitable based on objective data available in the bids e.g. eligibility data, Quantity/ Delivery etc.

In case of splitting in two, the ratio of 60:40, may be used - a different ratio may also be justified. These rat ios are approximate and India Government Mint, Kolkata reserves its right to marginally vary quantities to suit capacity of the firm/ unit loads of packing or transportation. However, the requirements may not be sp lit into a number of tenders of smaller quantities for the reason that one supplier may not be able to supply the entire quantity. It is also to mention in such cases that the firms should not quote for less than 25% of the tendered quantity; otherwise, their offer would be considered as unresponsive.

Before splitting the quantity, it should be ensured that the L1 price is reasonable. If it is not reasonable, ne gotiation with the L1 party may be carried out, if justifiable, with the approval of the CA. The following guid elines are to be considered while opting for parallel contracts:

- i) L1 should be awarded at least the percentage mentioned above or his spare supply capacity, whichever is lower; and
- ii) For the rest of the contract quantity, the lowest rate accepted will be counter offered to the L2 party. On acceptance of the counter offer, the order will be placed on L2 for the respective percentage or the spare s upply capacity of the L2 bidder, whichever is lower, and so on, to other tenderers. In case of non-acceptance of the counter offer by the L2 party, a similar offer shall be made to L3 and L4, and so on.
- **11.** The total cost inclusive of all as cited above on FOR India Govt. Mint, Kolkata (W.B) basis should be ind icated clearly both in words and figures in the price bid.
- **12.** Documentary evidence to be submitted towards PAN & GST Registration Certificate.
- **13.** Participating Bidder must submit sealed and signed copy of entire GeM bid document including the Bu yer Specification Document. Also the participating bidder must submit duly filled, sealed & signed **Annexu re I, Annexure II &** documents as per **Annexure III** in their letter head attached under Buyer Specificati on Document.
- **14.** All the supporting documents submitted along with this bid should be signed and sealed by the author ized signatory of the firm mandatorily. The bid document shall not contain any erasure or overwriting, exc ept as necessary to correct any error made by the tenderer and, if there is any such correction; the same s hall be initialled by the person(s) signing the tender.

Specifications of Fine Silver plate

1. Material: Silver of 92.5% purity (to be used with Copper as the other raw material). Purity is to be certified on invoice & indicated on the Silver plates.
