#### 2. Service & Support

#### 3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

Work to be started within Ten (10) days from the date of issue of contract & the contract will be valid for t welve (12) months.

Payment will be made on Monthly basis after receiving of original invoice along with other necessary docu ments and suitability by the user department of India Government Mint, Kolkata.

#### 4. Transportation of Domestic Goods:

#### 5. Packing:

#### 6. Insurance:

The supplier shall make arrangements for insuring the goods and services against loss or damage, inciden tal to manufacture or acquisition, transportation, storage and delivery. The Supplier shall be responsible til I the entire goods contracted for arrive in good condition at destination. The transit risk in this respect shal I be covered by the supplier by getting the goods duly insured. #### 7. Quantum of LD:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s ) incorporated in the contract, India Govt. Mint, Kolkata shall, without prejudice to other rights and remedi es available to India Govt. Mint, Kolkata under the contract, deduct from the contract price, as liquidated d amages, a sum equivalent to the 0.5% of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

#### 13. Price Schedule:

#### 14. MSME & Make in India Status:

#### **15. Price Preference for MSE:**

(ii) The word "origin" incorporated in this clause means the place from where the goods are mines, cultivat ed, grown, manufactured, produced or processed or from where the service are arranged.

If dispute or difference of any kind shall arise between India Government Mint, Kolkata and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably b y mutual consultations.
