1. 4. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. #### 1. Terms and Conditions:

#### 2. Delivery Period:

Service should be started from 19.04.2025 (after expiry of current 40 Mbps ILL service) and the service is t o be provided for a period of One (1) year i.e. 12 months.

Installation should be done within Fifteen (15) days from the date of issue of contract.

#### 3. Terms and Mode of payments:

- (i) Payment shall be made on monthly basis upon successful service provided at site subject to submission of bills on monthly basis which must certified by User Section of India Government Mint, Kolkata mentionin q that work has been completed as per conditions of work order/ Purchase order.
- (ii) One Time Installation charge will be paid with first month bill.

#### 4. Transportation of Domestic Goods:

To be borne by the supplier duly unloaded at the General store of India Govt. Mint, Kolkata.

#### 5. Packing:

Materials should be suitably packed. The packing should be weather proof and should be made water proof to prevent damage during transit. The supplier will also be responsible for unloading and stacking at India Government Mint, Kolkata Store as per instruction of competent authority.

#### 6. Insurance:

The supplier shall make arrangements for insuring the goods and services against loss or damage, inciden tal to manufacture or acquisition, transportation, storage and delivery. The Supplier shall be responsible til I the entire goods contracted for arrive in good condition at destination. The transit risk in this respect shal I be covered by the supplier by getting the goods duly insured. The insurance cover shall be obtained by the supplier in its own name not in the name of India Government Mint, Kolkata or its consignee. #### 7. Quantum of LD:

If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, India Govt. Mint, Kolkata shall, without prejudice to other rights and remedi es available to India Govt. Mint, Kolkata under the contract, deduct from the contract price, as liquidated d amages, a sum equivalent to the 0.5% of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed goods' or services' contract price(s).

- 12. The supplier has to provide GeM invoice during submission of bill for payment.

#### 13. Price Schedule:

While quoting the price through GeM portal, the detailed price breakup along with GST percentage must be mentioned and attached as pdf in the document attachment option of price bid mand atorily. Do not upload financial documents related to financial standings like audited balance sheets in the document attachment field of price bid, attach only the detailed price breakup of the quotation as mentioned above. #### 14. MSME & Make in India Status:

In case any bidder is submitting their bid as MSME and/or MII, the firm must be registered as a MSME & MII in GeM portal and Self-declaration along with documentary evidence in this regard must be submitted declaring that their MSME & MII status is updated in GeM portal also. In further evaluation stage if it is found that the firm is not registered as MSME and/or MII in GeM, but MSME certificate and/or MII declaration is submitted along with the bid, no exemption will be given and their offer may be rejected.

#### 15. Price Preference for MSE:

Being a Non-Split-able or non-dividable bid, the MSE quoting price within price band L1 + 15% will be awar ded full/complete supply of total tendered value provided they agree to match the L1 price, considering sp irit of policy for enhancing the Govt. procurement from MSE.

#### 16. Eligible Goods and Services (Origin of Goods & Services):

- (i) All goods and services to be supplied and provided for the contract shall have the origin in India or in the countries with which the Government of India has trade relations.
- (ii) The word "origin" incorporated in this clause means the place from where the goods are mines, cultivat ed, grown, manufactured, produced or processed or from where the service are arranged.
- **17. Special Condition:** Supplier should file the returns pertaining to TCS (Section 206C (1H) for TCS colle cted, in the time and provide the TCS certificate to IGMK. #### 20. Resolution of Disputes:

If dispute or difference of any kind shall arise between India Government Mint, Kolkata and the supplier in connection with or relating the contract, the parties shall make every effort to resolve the same amicably by mutual consultations. If the parties fail to resolve their dispute or difference by such mutual consultation within 21 days of its occurrence, then, depending on the position of the case, either the purchaser or the supplier shall give notice to the other party of its intention to commence arbitration. When the contract is with domestic supplier, the applicable arbitration procedure will be as per Indian Arbitration and Conciliation Act, 1996 as amended by Arbitration and Conciliation (Amendment) Act, 2015 and 2021. #### 21. Risk Purchase Clause:

Scope of Work with Terms & Conditions:

- **1.** End to End Solution of service should be provided by the vendor.
- 2. Unlimited Data Transfer.
- **3.** 24 by 7 Customer support service.
- **4.** Minimum Five static Public IP address of IPV4 pool should be provided by the vendor.
- **5.** Payment will be made on monthly basis.
- **6.** Connection should be Uncompressed & Unshared.
- **7.** Flapping link will be considered as downtime.
- **8.** The Service Provider shall do proactive monitoring and fault management of the network on an End-to-End basis remotely from its own Network Operations Centre (NOC) and provide the report through standard MRTG reports available through web access.
- **9.** Necessary power and communication cables to complete H/W installation including interfacing cables required for inter-connection of different equipment supplied by the vendor are in the scope of the vendor and shall be supplied at NO extra cost.
